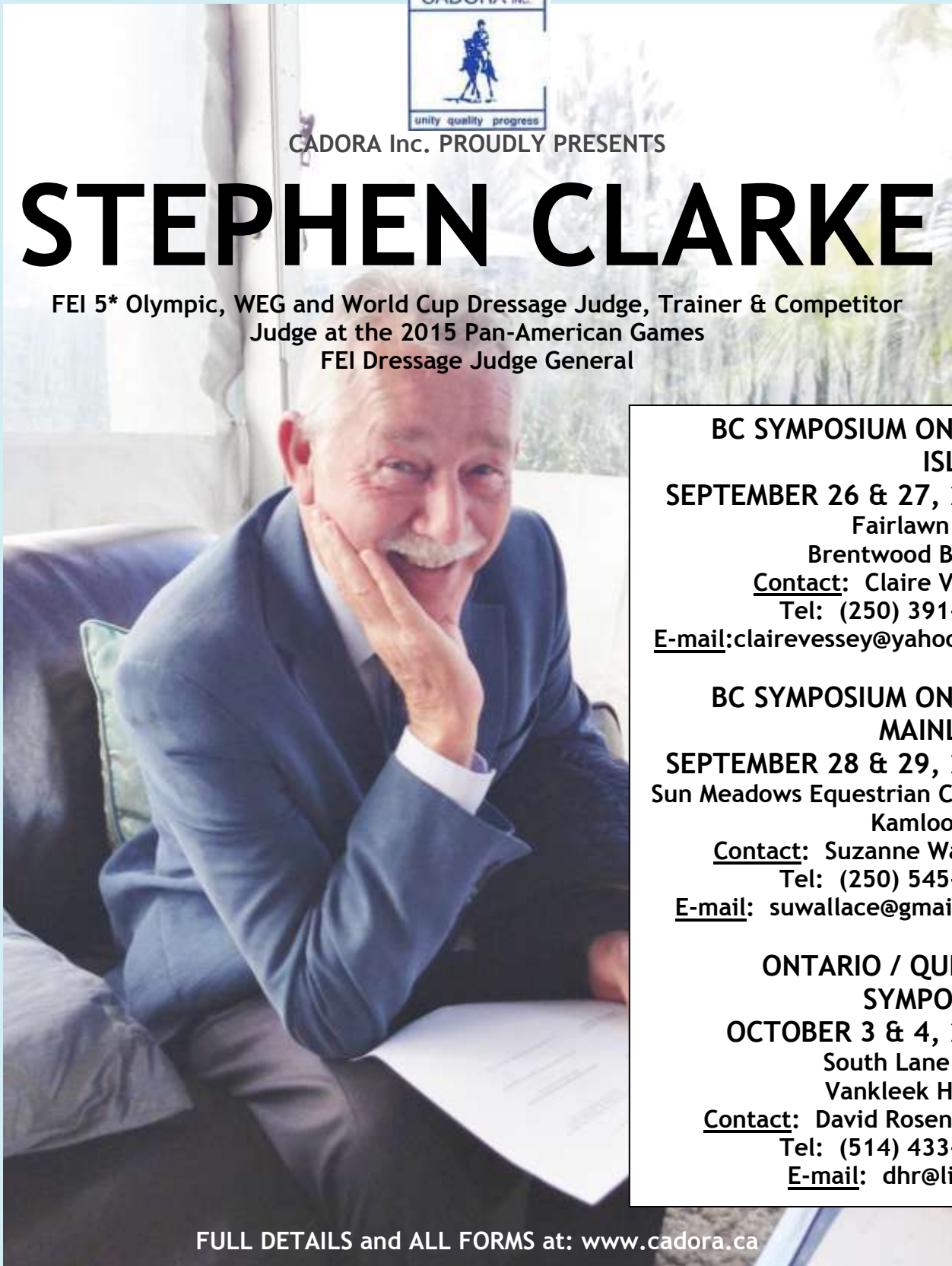

Participation fees: \$250./rider/lesson
